

**2020 CALL for NOMINATIONS  
for the GOVERNING COUNCIL  
of the CURRICULUM & PEDAGOGY GROUP**

All members of Curriculum and Pedagogy are invited to nominate themselves or others for membership on the Governing Council of the Curriculum & Pedagogy Group. According to the by-laws, "**membership in Curriculum and Pedagogy shall consist of those who have attended the annual conference of the association within the past three years.**" Both the individual nominating and the nominee must be members of Curriculum and Pedagogy Group. **Terms run January through December and are for three (3) years.**

The C&P Governing Council is responsible for maintaining the organization and ensuring its fiscal soundness. It is responsible for putting on an annual conference and publishing a professional journal. The Association By-Laws (Article V.b.5) require that "each member of the Council will have at least one specific responsibility during the year and is expected to attend the annual conference and council meetings in their entirety."

Council responsibilities require a commitment to active participation in the year-round work of the council. The council meets monthly via videoconference as a full council or a standing committee. Council determines policies, procedures, and guidelines consistent with the philosophy of the organization. All such decisions are subject to review and revision by the general membership who is the sole and final decision-making body of this organization. The general membership meets annually at the conference. Nominations will be accepted **electronically** (via email) until **Thursday, October 22, 2020 by 12pm**. Please send completed Nomination/Bio forms to Karla O'Donald ([k.odonald@tcu.edu](mailto:k.odonald@tcu.edu)). If you know of someone you believe would be a good candidate, please send his or her name and email address to the Nominations Committee, and a committee member will contact that person with an invitation to complete the Nomination/Bio form. In the event that the number of nominees equals the open seats the Council will present the nominees to the membership for a vote of acclimation without a ballot. If there are not enough nominations to fill the open seats by the deadline those that are submitted on time will be presented by council to the membership for a vote of acclamation.

Submission of the **Nomination/Bio Form** represents the candidate's acceptance of nomination to the voting ballot, and so must be received by the nominations deadline **(October 22, 2020)**.

On **October 23**, the compiled bios of the nominees will be presented to the C&P members.

Voting will be conducted at the Conference on October 23. **Election results will be announced at the Town Hall meeting on Friday, October 23.**
